Major Responsibilities and Duties:

Maintenance and Repair

- 1. Prepare surfaces for painting, including sanding and removing old paint, filling holes, cracks, and joints with appropriate filler. Tape, float, and texture walls and ceilings.
- 2. Select premixed paints or mix required portions of pigment, oil, and thinning and drying substances to prepare paint to match specified colors.
- 3. Paint surfaces, using brushes, spray gun, paint rollers, or other methods to achieve required effects. Stain, seal, and varnish wood surfaces.
- 4. Erect scaffolding, set up ladders, or use hoists to perform tasks above ground level.
- 5. Pick up and deliver painting supplies to campuses; maintain delivery records.
- 6. Receive and complete work orders. Identify and complete needed repairs on buildings, grounds, and equipment using established inspection procedures. Maintain accurate records on material and labor used.

- 7. Maintain inventory of tools and assist with inventory control of materials and equipment.
- 8. Inspect jobs after completion and ensure areas are clean.
